Balloting Details

- To be eligible for the balloting, duly filled-in complete Booking Form along with (i) accompanying documents; and (ii) the Token (see table above), will have to be submitted, by the 7. deadline specified by Bahria Town. Submission and receipt of a complete Booking Form does not constitute any confirmation or representation regarding successful allotment.
- Successful booking applicants will be determined through computerized balloting. The successful applicants so determined shall be obliged to comply with the terms and conditions of booking and allotment as per the provisions below. Upon successful application, the applicant's relevant Registration in his/her original project (i.e., Bahria Town Icon/ Opal 225/ Hoshang Pearl/ Bahria Town Tower, as applicable) shall stand cancelled.

Payment Details

Property Details

- A house once allotted or transferred cannot be surrendered or applied for cancellation by the applicant and all amounts paid on account thereof shall be NON REFUNDABLE. - Transfer of house allotted to an applicant shall be allowed only after receipt of updated payment/ charges. All registration/ mutation charges shall be borne by the allottee.
